Mayor Johnson called the meeting to order and welcomed all. Councilmember Wells led the prayer and Pledge of Allegiance to the flag.

**APPROVAL OF MINUTES:**

Mayor Johnson presented the minutes from the regular meeting on October 3, 2017. Councilmember Griffin moved to approve the minutes. Councilmember Sconiers seconded the motion which passed unanimously.

**COUNCIL APPROVED APPROPRIATION FROM THE CAPITAL ACCOUNT FOR JOHNSON PARK'S GYM ROOF REPLACEMENT:**

Mayor Johnson presented a proposal from Wyatt Sasser Construction for the replacement of the roof in the gym at Johnson Park. Councilmember Powell moved to approve the project and to appropriate \$25,560 from the capital account to cover the expense. Councilmember Sconiers seconded the motion which passed unanimously.

**COUNCIL APPOINTED A MEMBER TO THE ANDALUSIA HOUSING AUTHORITY:**

Mayor Johnson presented an application from Lena Boswell for an opening on the Andalusia Housing Authority. Councilmember Griffin moved to appoint Lena Boswell to the Housing Authority. Councilmember Wells seconded the motion which passed unanimously.

**COUNCIL APPOINTED A MEMBER TO THE TOURISM AND RELOCATION COMMITTEE:**

Mayor Johnson presented an application from Patricia Palmore for an opening on the Tourism and Relocation Committee. Councilmember Griffin moved to reappoint Patricia Palmore to the Tourism and Relocation Committee. Councilmember Mount seconded the motion which passed unanimously.

**COUNCIL APPROVED A MEMORANDUM OF UNDERSTANDING AND AN APPROPRIATION FROM CONTINGENCY FOR THE WIREGRASS TRAIL PROJECT:**

Mayor Johnson presented a Memorandum of Understanding by and between Geneva County, the City of Opp and the City of Andalusia for the purpose of developing the Wiregrass Trail Project. Councilmember Powell moved to authorize the mayor to sign the memorandum of understanding and to appropriate \$50,000 from contingency to cover part of the costs of an environmental survey in support of the project.
