**A RESOLUTION FOR APPLICATION TO THE CORONAVIRUS STATE FISCAL RECOVERY FUND  
AND THE CORONAVIRUS LOCAL FISCAL RECOVERY FUND ESTABLISHED UNDER THE  
AMERICAN RESCUE PLAN ACT**

**WHEREAS**, the Secretary of the Treasury has issued an interim final rule to implement the Coronavirus State Fiscal Recovery Fund and the Coronavirus Local Fiscal Recovery Fund established under the American Rescue Plan Act; and

**WHEREAS**, it is expected that the City of Andalusia will have such funds available for use on projects that are qualified under such interim final rule; and

**WHEREAS**, the City Council of the City of Andalusia, Alabama wishes to designate certain projects to be funded from said fiscal recovery funds; and

**WHEREAS**, the City Council also finds that the PPE, Personal Protection Equipment, will also qualify as an expenditure under the interim final rule in that such equipment; i.e., of gloves, masks, sanitizer, aerosol spray, fogging chemicals, etc., will aid in protecting City employees and visitors at City facilities from the Coronavirus. Such expenditure shall not exceed \$10,000.00.

**WHEREAS**, the City Council also finds that twenty Avon Facemasks, NFPA 2013 CBRN, are specialized to aid firefighters in hazardous respiratory conditions. Such expenditure shall not exceed \$19,560.00.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ANDALUSIA**, that the expenditures in the amount of \$29,560.00 for the application to the Coronavirus State Fiscal Recovery Fund and the American Rescue Plan Act are approved.
