**WHEREAS**, J.M. Jackson Chevrolet Buick cannot provide one of the vehicles, a 1500 2WD crew cab pickup truck.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ANDALUSIA**, that the Mayor and city administrator be authorized to purchase a 1500 2WD crew cab pickup truck, not to exceed \$40,000, from the Alabama Department of Revenue's list of preferred vendors, commonly referred to as the "state bid list," who meet or exceed the bid laws of the State of Alabama
